EXCLUSIVE VENUE HIRE

During peak months May to September inclusive & December: £4500

During off-peak months January to April inclusive and October & November: £3000

Monday to Thursday by negotiation

All prices are subject to VAT.

Venue Hire does not include food and drink, this will be quoted separately.

A deposit of £1000 is required to secure your booking.

INCLUDED IN THE VENUE HIRE:

- Use of the venue the day before to set up if required
- Exclusive use of the venue all day on the day of your wedding until Midnight
- Tables & chairs
- Ivory table linen
- Place settings (including crockery & cutlery)
- All necessary glassware
- Service of accompanying wines and drinks.

TERMS AND CONDITIONS

1. All prices quoted in our special quotation are correct at time of writing. We reserve the right to alter price or quotation at any time prior to the function. An alteration in price will only occur if we suffer an increase in our costs, and/or your requirements change.
2. Bar and wine prices are correct at the time of printing, but such items are subject to alteration without notice.
3. Approximate numbers of guests must be supplied on booking your function and a guaranteed number of guests are required at least five days before the function.
4. The charge will be based on the guaranteed number or the actual attendance, whichever is the greater.
5. A deposit of £1000 will be taken as confirmation of booking. The remaining amount must be paid in full at least 14 days prior to the event.
6. Cancellation of bookings: If you cancel your function, you will be subject to cancellation fees as set out below.
Cancellation fees:
Up to 28 days before the function – 20% of the total price plus the deposit.
Between 28 days and up to 7 days before the function - 50% of the total price plus the deposit.
7 days before the function – 100% of the total price plus the deposit.
7. Prices are subject to Value Added Tax unless marked otherwise.
8. The hirer is responsible for all breakage or loss of equipment, stock and/or hire furniture, or any damage caused whatsoever to the clubhouse and its surrounds during the period of hire. These will be charged at replacement cost.
9. Hurtwood Park Polo Club shall not be liable for any non-fulfilment due to causes beyond the owner's control.
